



# Responsible Management of Licensed Venues (RMLV) Course

Approved by the Queensland Office of Liquor & Gaming Regulation

Thanks for your interest in our Responsible Management of Licensed Venues (RMLV) Course. RSA Liquor Professionals conducts our regular monthly courses upstairs at the Caxton Hotel, 38 Caxton Street, Brisbane only a short walk from the Brisbane CBD. The course fee is only **\$395.00** per student for a 2 day course including all training material, enrolment fees and issue of an OLGR approved training course certificate. Free onsite car parking, morning tea, lunch and afternoon tea is provided on both training days at no additional charge. Students are required by OLGR to show acceptable ID to the course trainer so please ensure to bring along your ID.

Our training is conducted by Russell Steele, an approved trainer with BARS Training Australia, who are an OLGR approved RTO (National Provider Number 32061) responsible for issuing the RMLV Training Course Certificate upon successful completion of the course.
